SECOND AMENDMENT TO AMENDED AND RESTATED BYLAWS OF LIME TREE VILLAGE COMMUNITY CLUB ASSOCIATION, INC.

WHEREAS, that certain Amended and Restated Bylaws of Lime Tree Village Community Club Association, Inc. "Bylaws" was recorded at Official Records Book 7312, Page 3624, Public Records of Orange County, Florida;

WHEREAS, Section 8 of the Amended and Restated Bylaws states that the Bylaws may be amended at any time by the affirmative vote of two thirds (2/3) of the members voting in person or by proxy at a duly called meeting of the Association at which a quorum is present.

NOW THEREFORE, the Members hereby amend the Amended and Restated Bylaws as follows:

- 1. Section 5.1 of the Amended and Restated Bylaws of Lime Tree Village Community Club Association, Inc. is amended to read as follows:
- 5.1 Officers and Elections. The executive officers of the Association shall be a President, Vice-President, Treasurer and a Secretary, all of whom shall be elected annually by the membership and all of whom must be members of the Association. Except for the Secretary and Treasurer, no officer shall serve in the same office for more than two (2) consecutive terms.
